



LIMITED WARRANTY

STI, the maker of "Revolution Fabrics," provides this warranty to the original owner of the home furnishings product made with STI "Revolution Fabric" and covers STI's "Revolution Fabrics" only.

## FABRIC WARRANTY

#### WHAT THIS WARRANTY COVERS

This warranty covers Revolution Fabric only.

# WHAT THIS WARRANTYPROTECTS AGAINST

This warranty protects against Revolution Fabrics becoming unserviceable due to color or strength loss from normal indoor usage and exposure conditions.

## WHO THIS WARRANTY PROTECTS

This warranty protects the original purchaser (consumer of the home furnishing product using the Revolution Fabrics

## WHO CONSUMERS SHOULD CONTACT

Revolution Fabrics is normally a component of an end product such as home furnishings. Original purchasers/consumers should contact the retailer from whom the end product was purchased; retailers will be responsible for contacting their manufacturer; manufacturers will be responsible for contacting STI.

## LIMITS TO THE WARRANTY

STI's liability is expressly limited to this warranty. STI reserves the right to inspect the fabric submitted for claim. Revolution Fabrics must be kept clean using Revolution Cleaning Guidelines. Deviating from the cleaning guidelines, allowing the fabric to become excessively soiled without cleaning, and unreasonable or excessive use or any abuse by pets or people voids the warranty.

## WHAT THIS WARRANTY DOES NOT COVER

This warranty does not cover abnormal wear and tear, damage from misuse or abuse, improper installation; or costs associated with replacement of the fabric, (including labor and installation), consequential or incidental damages. The warranty does not cover any fabric that has been treated with a stain repellent treatment, stain repellent treatment is not necessary and will damage the fabric.

#### WHAT WE WILL DO

STI must receive proof of purchase and a sample of the fabric to determine if it meets the warranty requirements. If so, replacement fabric, including shipping, will be provided to the original purchaser. STI will supply new equivalent fabric to replace any Revolution Fabrics that are determined by STI to have become unserviceable in accordance with this warranty.

## WARRANTY COVERAGE PERIOD

This warranty covers replacement of the fabric for three years from the original date of purchase.

ALL WARRANTIES ARE TO THE ORIGINAL PURCHASER FROM RETAILERS SUPPLIED BY AUTHORIZED MANUFACTURERS ONLY. WARRANTIES ARE NOT TRANSFERABLE. ALL WARRANTIES ARE LIMITED TO MANUFACTURING AND MATERIAL DEFECTS THAT APPEAR UNDER NORMAL, INDOOR RESIDENTIAL USE. ADDITIONAL LIMITATIONS DESCRIBED HEREIN APPLY. WARRANTIES ARE FOR REPAIR, REPLACEMENT, OR SUBSTITUTION ONLY, IN STI'S SOLE DISCRETION. REFUNDS ARE NOT AVAILABLE. THESE WARRANTIES ARE YOUR EXCLUSIVE REMEDY AND NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, APPLY. IN NO EVENT WILL STI BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, EVEN IF IT HAD REASON TO KNOW IN ADVANCE THAT SUCH DAMAGES WERE POSSIBLE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER RIGHTS THAT VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES OR THE LIMITATION OF DAMAGES SO THE ABOVE EXCLUSION AND LIMITATIONS MAY NOT APPLY TO YOU. IN THE EVENT THE WARRANTY EXCLUSIONS DO NOT APPLY TO YOU, THEN, WHERE LEGALLY PERMISSIBLE, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD AND NO WARRANTIES APPLY AFTER THAT PERIOD.
